

CONDITIONS OF SALE

Customers are reminded that, in accordance with article L. 121-21-8 12° of the Consumer Code, they do not have a right of withdrawal as provided for in article L. 121-21 of the Consumer Code. The Terms and Conditions of Sales for the selected price specify the procedures for cancelling and/or modifying the reservation.

1 - RATES:

. They do not include visitor's tax. Children under 4 years of age are free of charge.

Camping pitches: our basic rate is per day from midday to midday for 1 pitch, 1 tent, caravan or camper, 3 persons, 1 car and access to the swimming-pool, on the basis of two entrances per person per night paid.

Maximum of 6 persons, 3 units and 1 car per pitch.

Rental: our tariff is for a rental including equipment, with the number of persons not exceeding the capacity of the accommodation.

People under 18 are not accepted on the campsite without one of their parents.

2 - RESERVATIONS:

Camping: In the high season, bookings are for 7 nights minimum.

From 17/07 to 21/08/2021, arrivals and departures are only possible on Tuesdays and Saturdays.

From 01/07 to 16/07 and from 22/08 to 31/08/2021 reservations are for 2 nights minimum.

Rental: In the high season, bookings are for 7 nights minimum.

For a bungalow: between 17/07 and 28/08/2021 arrivals and departures are possible on Tuesdays and Saturdays

For a mobile home: between 30/06 and 05/09/2021 arrivals and departures are possible on Wednesdays and Sundays

For a chalet: between 29/06 and 04/09/2021 arrivals and departures are possible on Tuesdays and Saturdays

3 - DEPOSITS:

. Campsite: firm reservation is made on receipt of a deposit, amounting to 30% of the booking price, with a minimum of 40 euros. Payment of the balance on arrival.

. Rental: firm reservation is made on receipt of a deposit, amounting to 30% of booking price.

Payment of balance:

- MOBILE HOMES and CHALETS: 3 weeks before arrival. Last minute booking should be totally paid at the reservation

- BUNGALOWS: 3 weeks before arrival in high season. On arrival in low season except for Triathlon, Pentecost and Ascension

4 - CANCELLATION

. Cancellations must be made by registered letter.

. If a reservation is cancelled more than four weeks before the date of arrival, the deposit (and any balance paid for rentals) will be refunded in full, cancellation charges deducted (30 euros). Enclose bank account details with your bank's full address).

- If a reservation is cancelled less than four weeks before the date of arrival, the deposit (and any balance paid for rentals) will be retained except if you have taken a cancellation insurance and if your event is covered by the policy.

5 - DELAYED ARRIVAL:

. Reservations are valid for 48 hours after the planned date of arrival. Beyond this time, if we don't have any word from you, the reservation will be cancelled and the payment retained.

6 - INVOICING:

. In high season, invoices are made on the basis of the period reserved regardless of actual arrival and departure dates.

7 - PETS:

. Campsite: Pets will be accepted upon presentation of a certificate of health and record of up-to-date vaccinations. In addition, they must be tattooed and kept on a leash within the limits of the campground. Dogs are prohibited from the beaches. Dogs of Category 1 and 2 are forbidden.

. Rental: animals are strictly prohibited from rented accommodation.

8 - MANAGEMENT RESERVES THE RIGHT:

. To refuse a reservation without disclosing its reasons.

. To expel any trouble-makers, disturbers of the peace and anyone causing damage to property or persons.

9 - SECURITY:

. We refuse to accept responsibility for theft on the campsite, from tents, caravans, bungalows, Mobil-homes, chalets or cars. Safe deposits for hiring are available for customer's use at the reception desk.

. Standard NFC 15100 requires the provision of a 3-pin electrical outlet (live, neutral and earth). Connections which do not meet this requirement will not be tolerated. All connections in the campsite are European.

10 - INSURANCE:

. It is stipulated that customers must hold a civil liability policy covering any bodily and material damage for which they may be responsible.
